## Well-child visits

The American Academy of Pediatrics (AAP) has noted a significant decline in well-child visits and subsequent vaccinations and appropriate screenings. For this reason, the AAP developed guidance on the provision of pediatric well-care services via telehealth during the COVD-19 pandemic. This guidance recommends that well-child visits should occur in person whenever possible. AAP notes that well visits for children may be initiated through telehealth, however some elements of the well exam should be completed in person. Providers that have implemented telehealth are encouraged to provide appropriate elements of the well-child exam virtually, followed by a timely in-person visit.<sup>1</sup>

Additionally, providers are strongly encouraged to have a process in place to monitor and ensure the in-person component of the well-visit is scheduled and completed. This guidance does not change the current billing guidance for telehealth visits; however, providers should **not** bill for both parts of the exam. The telehealth and secondary in-person visit are considered part of the same well visit exam and may only be billed for once, at the completion of the telehealth component.

Components of well-child visits that may be offered through telehealth include:

- Visual physical exam
- Health historyMental development
- Physical development Anticipatory guidance
- Developmental screening
- Nutrition counselingWeight assessment

ACEs screening Age-appropriate SHA/IHEBA

Exercise counseling

Components of well-child visits completed in-person may include:

- Anthropometric measurements
- Office or laboratory testing
- Hearing, vision, and oral health screening
- Fluoride varnish application
- Immunizations<sup>2</sup>
